Adjuster Training

We offer both All Lines Adjuster Training and review for the Public Adjuster exam.

If you desire to work for an insurance company as an independent adjuster or an employed adjuster, you will want to take All Lines Adjuster Training. Our course is approved by the Texas Department of Insurance (Provider No. 32319), so it includes two chances at the approved exam. An All Lines license will allow you to adjust any type of claim from catastrophe to workers compensation.

We offer a review course for individuals desiring to become Public Adjusters. These individuals represent property owners in property-only claims. In order to become a Public Adjuster, you must pass the state-approved exam at Thomson-Prometric and post a bond.

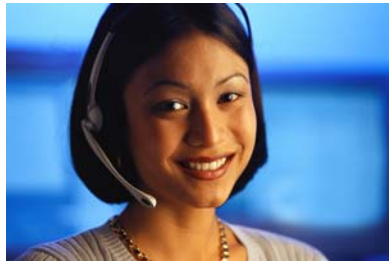
